PLEASE READ CAREFULLY

If you are not an enrolled Eastern Shoshone or Northen Arapaho Tribes member, you will need to purchase a Shoshone and Arapaho Tribal Permit and a Recreation Stamp if you will be departing from the following Shoshone National Forest-Popo Agie Wilderness trailheads, OR traveling or fishing anywhere on permitted areas of Wind River Indian Reservation:

Smith Lake/North Fork Trail Trailhead (Dickinson Park)

Bears Ears Trailhead (Dickinson Park)

Or anywhere out of Dickinson Park if you travel to Dickinson Park in a vehicle.

You have several permit options. However, most people will choose a daily permit. You will need a permit that covers for the specific date(s) you will be traveling across Tribal lands to the USFS-Shoshone National Forest Trailheads. This means you will need one for your entry date and one for your exit date PLUS one Recreation stamp, for <u>each person in the vehicle</u>. Or an annual permit PLUS one Recreation stamp, or a 7-day permit that covers your days on Tribal lands PLUS one Recreation stamp.

Recreation Stamp: \$20.00

Resident Fees: Annual \$95.00, 1-day \$35.00, 7 day \$65.00, Senior Citizen Annual (60 yrs and older) \$45.00, Youth (15 yrs to 17 yrs) Annual \$20.00, Handicap \$30.00, Under 15 yrs no charge.

Non-Resident Fees: Annual \$135.00, 1-day \$40.00, 7-day \$90.00, Senior Citizen Annual (60 yrs and older) \$70.00, Youth (15 yrs to 17 yrs) Annual \$35.00, Handicap \$30.00, Under 15 yrs no charge.

TYPICAL TRIP EXAMPLE: Smith Lake TH departure on August 15th and return on August 19th, you will need TWO permits, one for August 15th AND one for August 19th PLUS one Recreation Stamp. Total Non-Resident cost under 60 years old is \$100.00 and total Resident cost under 60 years old is \$90.00. Non-Resident Senior Citizens (60 yrs and older) should opt to purchase the annual for \$90 (\$70 + \$20). Resident Senior Citizens (60 yrs and older) should opt to purchase the annual for \$65 (\$45 + \$20).
